Motion carried.

Bonding Attorney's submitted letters notifying the Jury that Board Members of Evangeline Parish Ward 1 Fire District #2 are trying to acquire funding to build a new fire station on Hwy. 167 North of Ville Platte to provide response to the Chicot Park Road and the Kennedy Sub areas. Approval to borrow money from the bonding commission is being handled by Foley and Judell. Plans are to have the taxes on the December 10th ballot in hopes to renew the taxes for 20 years. A public meeting will be held Tuesday, August 9, 2022 at 6 p.m. at the Lincoln Road Fire Station, 309 Lincoln Rd., Ville Platte, La. The Board of Commissioners of Fire Protection District #2 of Evangeline Parish plans to consider adopting a resolution ordering and calling an election to be held in Fire Protection District #2 to authorize the extension of advalorem taxes.

The Committee then reviewed members of Boards and Commissions throughout the Parish. Some member's terms are expired and need to be reappointed along with some having no expiring term. The Jury will discuss further at the next meeting.

Motion was made by Sidney Fontenot and seconded by Ryan Williams to approve a letter of intent to submit an application to Natural Resources Conservation Services (NRCS) for a potential Public Law (PL) 566 Project and also requesting the Soil and Water Conservation District Board to be a Co-Sponsor of said project.
