Personnel Committee August 7, 2023

The Personnel Committee met with the following members present: Kevin Veillon, Lelia Thrasher, Bryan Vidrine, and Sidney Fontenot. Absent and excused was Daniel Arvie. A quorum was present.

Mr. James Fontenot, Water/Sewer Maintenance Supervisor addressed the Jury regarding a write up. Mr. Fontenot stated that he had an episode on Main Street in hitting a hole on the edge of the road. At the time when obstructed, he felt he didn't need to report being there was no damage to property or to himself. After days went by, Mr. Fontenot stated that he started feeling some distresses and had not reported the incident with the Police Jury Office until days later, due to no affects at the time. Mr. Fontenot does not feel he should have been written up being there was no accident to report. Chairman, Bryan Vidrine stated that there was an accident with an injury. Policy states that any accident occurring during normal working hours shall be reported to the immediate supervisor at once. The supervisor shall, in turn, notify the Secretary-Treasurer. Upon notification of an accident, Human Resource Department shall complete an accident form which must be forwarded no later than 48 hours after the accident, in order that an employee may be covered under Worker Compensation Insurance. Mr. Vidrine stated that is the reason for the write up because it was not reported until 3 days after the incident.

Mr. Vidrine is recommending in having cameras/monitors installed in parish vehicles to see when accidents do happen and no questions as to what took place.
