A lawsuit was filed years ago regarding Opioids and a settlement has been finalized, which has brought funds to the Parish these past two years. These funds can be utilized within the guidelines of what the settlement required. District Judges have been working with our Legislative and came up with a plan for a Opioid Drug Court. A cooperative endeavor agreement will be entered into with the Thirteenth Judicial Court of Evangeline Parish if the plan meets all guidelines.

Judge Chuck West and Judge Marcus Fontenot addressed the Jury explaining that if all guidelines are met this Court will be treatment related, not law focused. Once a draft agreement is in place it will be brought before the Jury for discussion and approval.

It was stated that funds for the cemetery ward are least funded. Inmates have been providing maintenance to build the fund up however at this time, funds are still not available to be able to afford contracting out. Juror Ryan Ardoin would like to see all parish wide cemeteries work together as one, which would have to be brought before the bond commission and the public. Motion was made by Kevin Veillon and seconded by Keith Saucier approving to gather more information on what is needed to move forward. Motion carried.

Road and Bridge Committee February 5, 2024

Parish road use permits were discussed. Juror Tim Causey stated to the Jury that Evangeline Road which is located in Ward 4 has been damaged by Logging Company's. Currently the parish has a \$7,500 bond and would like to have some changes made to the permit requirements and fees. More information will be gathered in moving forward and brought back before the Jury at next month's meeting.

Secretary-Treasurer mentioned there have been complaints by property owners on some parish roads which have been abandoned recently by the Jury. Owners feel they were not notified of the abandonments. Juror Tim Causey mentioned that not all constituents receive the paper and have no way of knowing about abandonments and is requesting if this can be changed. Legal Advisor stated that unfortunately a lot of the public notice information is sent by State Statutes. Local governments have to comply with the Statutes, which is publication in the official journal. The Jury does not have the authority to ignore or change without going through a local bill in the Legislature. It was also questioned if there is a way the abandonment can be reversed or undone. Legal Advisor stated this would have to be researched.

Due to the drought extremely, large cracks have been created in some parish road foundations. There are concerns on how to move forward with repairs. Information on a machine is being checked on from another parish to see how it works. Once that information is gathered this will be brought back to the Jury for discussion.

A used vehicle for District 7 Litter Abatement Crew is being looked into.
