The Executive Committee met with the following members present: Bryan Vidrine, Kevin Veillon and Sidney Fontenot. Absent and excused were Keith Saucier and Ryan Ardoin. A quorum was present.

Agenda Item#2, Vandenburg Cemetery Board, will be tabled at this time.

Public Works Director addressed the Committee with a CDL report. CDL courses for certain road crew employees will cost \$2,000 per person which will consist of on the road training and CDL license test. Motion was made by Sidney Fontenot and seconded by Kevin Veillon to approved up to four (4) employees for CDL license training courses. Motion carried.

Mr. Rufus Serialle addressed the Committee regarding Evangeline Parish Coroners Office. Mr. Serialle stated that information he requested for autopsies ordered has been received for the fiscal year 2021-2023. Concerns are why is the Coroner receiving funds and paying another party to respond to cases, who in his opinion, are not qualified to be providing this kind of service. Chairman, Bryan Vidrine, stated that the Jury does not determine whether or not the Coroner is doing his job. The Jury has a duty that the Constitution of Louisiana requires, which is the Parish has to fund what the Coroner deems reasonable.

Chairman, Bryan Vidrine, brought up the topic of communication of Jurors with employees for informational purposes to the public. The Jury has to abide according to standards and laws set in place. Individual jurors are prohibited from giving orders or instructions to employees related to day-to-day operations. All orders are to be given by superintendent or other supervisory employees to transmit complaints, problems or work order requests.

The Committee then discussed amending the Cooperative Endeavor Agreement (CEA) for a \$200,000 maintenance grant. Motion was made by Sidney Fontenot and seconded by Kevin Veillon approving to amend the CEA to include Semi-trailer truck enabling the Parish to transport heavy equipment throughout the Parish, a heavy-duty backhoe enabling the Parish to properly maintain roadways, sewer and drainage needs and a tractor with attachments used to maintain facilities at Crooked Creek Recreation Area and assist with maintenance of beautification projects and emergency preparedness. Motion carried.

Motion was made by Kevin Veillon and seconded by Sidney Fontenot approving to enter into a Cooperative Endeavor Agreement with Evangeline Parish Tourism in working together providing the parish with a grant coordinator/administrator and also approve moving forward with the advertising to hire a grant coordinator/administrator position. Motion carried.

Motion was made by Kevin Veillon and seconded by Sidney Fontenot approving to adjourn the Executive Committee meeting. Motion carried.
