Application for the DRA Grant for the Courthouse Annex Building (Economic Development Building) will need to be submitted by July 9, 2024. Supporting documentation is being gathered at this time to submit with the application.

It was mentioned that the LGAP Grant for expansion of the Industrial Park sewer treatment plant will be included in the new jail facility project. This grant is now available for another project. Motion was made by Ryan Ardoin and seconded by Sidney Fontenot to approve amending the existing LGAP Grant in the amount of \$21,428 to be used for upgrading the parish licensing software. Motion carried.

A discussion was held regarding the policy of purchasing equipment. It was mentioned that any equipment needs to be brought before the Jury if purchased over \$10,000. A new policy will be drafted and brought before the Jury at the next meeting for discussion. Motion carried.
